



2018 ITPAC Report

Through August 31, 2018, the Indiana Title Political Action Committee (“ITPAC”) has raised \$10,112 this ITPAC “year”, which runs from November 1st to October 31st every year to coincide with ILTA Membership renewals.

The money raised this ITPAC year was through private individual and corporate ITPAC contributions and from fundraising opportunities provided throughout the entire year. This year fundraising opportunities were provided at the ILTA Underwriting Seminar (Nov 2017), ILTA Lobby Day (Jan 2018), ILTA Title Basics Seminar (Feb 2018), the ILTA Track Day (May 2018) with the popular returning of the ITPAC 500 and the auctioning of the “Indy Racing Tour”, and the Summer Extravaganza: Beyond the Basics I (June 2018). The ITPAC Auction this year is looking to be a positive fundraising experience again as we use the online platform and have opened it up once again to those attending convention and those are remote.

The current ITPAC balance is \$21,806.94 as of August 31, 2018. In 2018, ITPAC has contributed \$12,700 to various campaigns with further donations to follow during this year’s election. Also, ILTA members were able to participate in the Governor’s Shoot (Sporting Clays with the First Lady, Basketball with the Governor), and the House Republican Campaign Committee Barbeque.
