Proposed Amendments to ILTA Bylaws

The following changes have been proposed to our bylaws this year:

1. We are adding a Sponsorship Committee to "Article X – Committees" that will create a committee to help the executive director and the board to find vendors to sponsor the events.
2. The Underwriter Section has proposed the following changes:
 - a. Both the Underwriting Section Chair and Agents Section Chair would have a vote with any board action presented at any board meeting.
 - b. The ability to have a non-resident member to be able to be the Underwriter Section Chair.
